

**APPLICATION FOR 2022-2023  
CANDLEWYCK HOMES ASSOCIATION SOCIAL MEMBERSHIP**

The Candlewyck Homes Association offers a limited number of Social Memberships to non-Candlewyck homeowners. The annual fee for the Social Membership for 2022 is \$703.00 and is offered to homeowners of the Providence Springs, Foxglove, and Vizcaya neighborhoods.

For new Social Membership applicants there is an initial initiation fee of \$170.00. If at any time you let your membership lapse, you will need to complete the membership process again, including payment of the prevailing initiation fee, to re-join.

As of April 1, 2018, any Social Member who moves to a neighborhood other than Providence Springs, Foxglove, or Vizcaya will no longer be eligible for a Social Membership to Candlewyck Homes Association. Those members who do not currently reside in the three eligible neighborhoods may retain their memberships until their current residence changes.

The Social Membership runs from April 1 to March 31, of the following year. If your application is not returned by April 1, you will be placed on a waiting list, if applicable.

Social Members in good standing are afforded the same non-voting rights and are bound by the same rules and regulations for use of the amenities, as Candlewyck Homes Association homeowners.

1. Amenities offered by Candlewyck Homes Association include the use of:

- Swimming pool during pool hours but excluding dates and times reserved for Candlewyck Swim Team practice and competition (go to [www.CandlewyckHomes.com](http://www.CandlewyckHomes.com) for schedules).
- Tennis courts from 7 am until 11 pm.
- Basketball and volleyball courts, the soccer field, and playground from 7 am until 11 pm.
- Walking Trails from 7 am until dusk.

2. Rules and Regulations for use of the pool are attached and are part of this Application.

By filling out and signing this application, and paying the annual fee, I knowingly assume all risks from using the amenities, and indemnify the Candlewyck Homes Association, their respective officers, directors, or contractors for all liabilities, claims, demands, losses, or damages of any kind arising from injury or damage to personal property while on the premises, or while participating in the activities of the Candlewyck Homes Association. I hereby give my permission to the Candlewyck Homes Association and its representatives to obtain emergency medical treatment.

## Candlewyck Pool Rules and Regulations

The Pool Manager and Lifeguards have the authority and jurisdiction over the conduct of any persons and/or circumstances involving the pool, subject to the approval of the Board of Directors.

It is the duty and responsibility of all members, their children, and guests to adhere to and encourage compliance with these rules. **CHILDREN'S CONDUCT IS THE INHERENT RESPONSIBILITY OF THEIR PARENTS.**

- All members and guests will sign in before using the pool and will show identification upon request to a guard on duty.
- Guests must be accompanied by the sponsoring member while in the pool area.
- Guest fees are the responsibility of the sponsoring member. Charge is \$3.00 per in-town guest. No more than four in-town guests per family at one time are allowed.
- All persons must take a shower before entering the pool.
- Only conventional bathing attire will be allowed.
- No cut-offs.
- Parents should encourage children to use toilets before entering pool.
- All children under 7 and non-swimmers ages 10 and under **MUST** be accompanied in the pool area by a **PARENT** or **OTHER RESPONSIBLE PARTY**.
- Non-swimmers will not be allowed beyond a point which they cannot safely stand with their heads above water.
- All persons will refrain from distracting the lifeguards.
- Everyone must leave the pool in the event of an emergency as signaled by the lifeguard.
- Flotation devices and pool toys may only be used if approved by the lifeguard on duty.
- Glass containers of any kind are not allowed in the pool area or bathhouse.
- All food, drinks must be confined to the seating area or tables. Trash must be disposed of properly.
- Running, pushing, wrestling and other rough play will not be tolerated.
- Diving is not permitted in the shallow end of the pool.
- Abusive and objectionable language will not be used.
- Radios, CD, and cassette players may only be used with headphones.
- Chewing gum is not permitted in the pool area at any time.
- Any distilled spirits, wine or beer should not be openly displayed.
- Candlewyck Pool will not be responsible for loss of or damage to personal property.
